

FREQUENTLY ASKED QUESTIONS ABOUT ERASMUS + PROGRAM

Which mobilities for students are on the Erasmus + Program scope?

Student mobility under the Erasmus + Program can be done for studies or for internships.

Which mobilities for teaching and non-teaching staff are on the Erasmus + Program scope?

The mobility of teaching and non-teaching staff under the Program may be carried out for training or for teaching.

Who can apply for Erasmus + mobility?

- Regarding the mobility program for Erasmus+ studies, all ENIDH students, regardless their nationality, who are enrolled in an undergraduate course and have completed the first year or 60 ECTS, can participate.
- For the mobility program for Erasmus+ internships, ENIDH students who, regardless their nationality, are recent graduates can participate.

Which is the minimum and maximum mobility period?

- For study mobility, the minimum period is 3 months and the maximum is 12 months.
- For internship mobility, the minimum period is 2 months and the maximum is 12 months.

For which Higher Education Institutions can I apply?

Which documents are needed to apply to Erasmus + Program?

- Application form for Student Mobility for Studies / Internship;
- Copy of the Citizen Card (or equivalent document);

- Academic Registration updated (Netpa consultation grades) for Studies, and for Internships, the Letter / Certificate of Course (or, if not yet available, the academic registration through consultation of grades in Netpa).

There is the need to have host mobility country linguistic knowledge?

No, it is not necessary. However, it is important to have basic knowledge on English language, in order to be able to communicate more easily. The assessment of language competence is contractually mandatory.

What is OLS – *Online Linguistic Support*?

Before the mobility start, Erasmus + Program participants can check their knowledge on host country language.

Online Linguistic Support consists of:

- Initial test (Test1) to assess the student's linguistic competence, before mobility start.
- Final test (Test2) to assess the student's linguistic competence, at the end of the mobility.

Can I have a scholarship?

Being an Erasmus + student does not necessarily imply that you have a scholarship. Yearly, ENIDH provides mobility scholarships for studies and for internships. The number of yearly scholarships depends on European Commission and National Agency fundings.

Which is the scholarship value?

The scholarship value is pre-defined by the National Erasmus + Agency for each academic year and depends on the level / cost of live in the destination country. Currently, there are three categories that divide the European Union countries.

How is the mobility scholarship payment?

ENIDH makes the payment by bank transfer in two phases:

- 70% before the mobility start. (After the financial contract signature and all documents sending);
- 30% at the end of the mobility and after to send all documents requested.

May I have to return the scholarship?

Yes. In case of withdrawal of mobility for reasons directly attributable to the student; for behavioural reasons, and if you have not success in all Course Units.

Can I do Erasmus + mobility without a scholarship?

Yes, but without funding and respecting the rules of the program.

Who selects the course units that I will attend at the destination institution?

The student will meet with the Pedagogical Committee of the International Relations Office (GRI) to identify the UC's that he will attend at the destination institution and their equivalences.

When I get to ENIDH do I have to deliver a document (Studies Mobility)?

At the end of the mobility, all students need to prove their mobility as well as their success through the Certificate of Attendance, Final Study Mobility Report and. They also need to successfully submit the Final Report on the European Commission's Mobility Tool platform.

When I finish the Internship, do I have to deliver a document (Internship)?

At the end of the mobility, all participants must prove their mobility as well as their success through the Certificate of Attendance, Final Internship Mobility Report, final OLS test and Learning Agreement After Mobility. They also need to successfully submit the Final Report on the European Commission's Mobility Tool platform.

How the grades will be attributed?

The GRI receives the grades through the Transcript of Records, the Personal Academic Certificate, or another document of the host institution. After, GRI sends it to the Academic Service, which, sends it to the Accreditation Commission. The grades are attributed after the approval of the Coordinating Committee of the Technical-Scientific Council.

Do I have to pay fees at ENIDH?

Yes, fees must be paid within the deadlines stipulated by the Academic Services. The mobility student needs to have his financial situation regularized at ENIDH.

Do I have to register at ENIDH in the semester / academic year in which I am going to do the mobility?

Yes, students must be enrolled in ENIDH in the course units that they will attend in the host institution. They also need to be enrolled when they apply to Erasmus + program.

Who is responsible for addressing accommodation and travel issues?

Accommodation is the responsibility of each student and not of the Host Institution or the Home Institution.
